Additional Information

The following narrative is scripted by Offender Tracking Detective S.N. Fusco, #5217:

The suspect, William Emile Joins, is a registered sexual offender with the State of Florida. He was convicted of Lewd and Lascivious Battery Victim 12-15 years of age (FSS 800.04 (4)) on 11/04/2013 in Jacksonville, Duval County, Florida. As such, he is required to register with the Florida Department of Law Enforcement (FDLE) and the Jacksonville Sheriff's Office every six months, during the months of May and November. In addition, the suspect is required to abide by all FDLE Sexual Offender Obligations outlined in F.S. 943.0435, 944.607 or 985.4815.

The suspect last reported to the Jacksonville Sheriff's Office Felony Registration Unit on 11/18/2019 to complete/update his FDLE Sexual Offender registration with a Logistics Officer at Felony Registration. Upon completion of his registration, the suspect electronically signed the registration, acknowledging that he understood his FDLE Sexual Offender Rules/Requirements.

On 11/23/19 I was assigned to check the offender for a new move address verification.

On 12/31/19 (0810) I went to the suspect's registered address of 4250 Camellia Circle East. When I arrived I observed the front yard of 4250 Camellia Circle East had numerous Christmas Decorations displayed. This is a violation of Municipal Ordinance 685.104 which states the following: Any person designated a Sexual Offender/Predator shall not place or allow any display, including but not limited to displays for any nationally or locally recognized holiday or seasonal event or practice, to be visible from the exterior of any Sexual Offender's or Sexual Predator's residence, including a vehicle or vessel, or on any property which is leased, rented, owned or occupied by such person, if such display is primarily targeted to entice, attract, or lure a child onto any residence or property, or onto or nearer to any vehicle or vessel rented, owned or occupied by such person. Enforcement of this section shall not be limited to the actual calendar date of any given nationally or locally recognized holiday or seasonal event or practice.

I also observed a Maroon Honda CRV (FL Tag #Z58EQI) parked in the driveway of the suspect's address. This vehicle was not listed on the suspect's last registration that was completed on 11/11/2019. There was no answer at the door, I left a card in the door requesting William Joins call me in reference to completing his verification.

At 1521, I received a phone call from the suspect. I advised the suspect when I went to his residence, I observed numerous Christmas Decorations in his front yard. The suspect said [REDACTED] advised the suspect since he is a registered sexual offender, he is not allowed to put up Halloween or Christmas Decoration at his residence and he was currently in violation of a city Municipal Ordinance. The suspect advised he did not he was not allowed to put up decorations at his residence because no one told him. He explained he will let his wife or she cannot put up decorations.

I then told the suspect there was a Honda CRV in the drive and asked who's vehicle that was. He advised the vehicle belonged to his wife, with whom he lives with. I advised the offender this was a violation of his Sexual Offender rules. The suspect stated he doesn't drive the vehicle. I advised the suspect if there is a vehicle that is registered to another occupant, who is living at his registered address, must registered the vehicle because he had access to the vehicle. The suspect advised he was not told he needed to register his wife's vehicle by the people at Felony registration. I advised the suspect he is an adult who has been on the FDLE Sexual Offender site for many years and it was his responsibility to read the twenty two rules that were provided to him on 11/18/19 and every time he registered prior to that. I advised the suspect he needed to report to Felony Registration on Thursday 01/02/20 to add his wife's vehicle. He advised he got off work at 1200 (noon) and would report to the registration office. I advised him the office was closed for lunch from 1200-1300. He advised he would be there at 1300.

It should be noted in 2014 the suspect signed the Sexual Offender/Predator Prohibited Activity Notification that cover the Municipal Ordinance Code 685.104.

On 01/02/19 I arrived at 1024 Superior Street and found the suspect's wife, Mrs. Shirley Simmons(Joins) was at the office trying to register her vehicle for the suspect. She was told she could not register the vehicle for the suspect and he must register it himself.

I explained to Mrs. Joins her husband since her husband was a registered sexual offender he could not display any Halloween or Christmas decorations at the residence he is living at. I also explained no candy could be handed out at his residence either. A copy of the sex offender twenty two rules was given to Mrs. Joins at her request.

Due to the Toyota Gator Bowl game, non -essential personnel were advised to leave at 1330 for the rest of the day. I called the suspect back at his registered number (904-288-1059) at 0912 and left a voicemail message advising the office was closing at 1330 and he needed to be there at 1300-1315..

Since the suspect did not register his wife's vehicle when he registered on 11/18/19, he was in violation of FDLE Rule # 9 which states the following: I MUST report any changes in vehicles owned within 48 hours in person at the sheriff's office. (F.S. 943.0435(2)(b)3.; 775.21(6)(a)1.d.). FAILURE TO REPORT THIS INFORMATION WITHIN 48 HOURS IS A THIRD DEGREE FELONY.

The following narrative is scripted by Offender Tracking Detective T.J. Calderon:

On 01/02/20 at approximately 1330 the suspect arrived in Felony Registration. I made contact with the suspect and advised him of his constitutional rights. The suspect stated that he understood. The suspect agreed to speak with me.

I asked the suspect about the unreported vehicle. The suspect [REDACTED]

I asked the suspect about the Christmas decorations. The suspect advised that his wife put up the decorations for her grandchild. The suspect advised that he did not know she was going to put them up [REDACTED]

The suspect was arrested and transported to the PTDF.

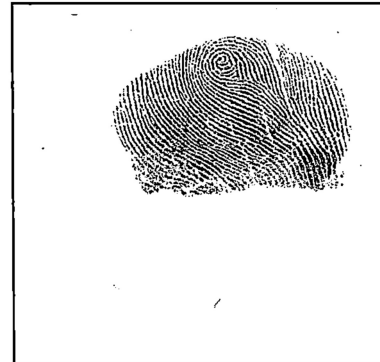
